1. This Form 3 is being filed by BNP Paribas, a French societe anonyme and bank holding company under the Bank Holding Company Act of 1956, on behalf of its wholly-owned subsidiaries.

2. On November 30, 2009, in accordance with the Fourth Amended Joint Plan of Affiliated Debtors Pursuant to Chapter 11 of the Bankruptcy Code, dated October 27, 2009 and filed as Exhibit 2.1 to the Issuer's Form 10, filed May 6, 2010, the Issuer issued 1,565,375 shares of Class A Common Stock to BNP Paribas and 3,113,443 shares of Class A Common Stock to Fortis Capital Corp. On April 13, 2010, Banexi Holding Corp., a direct wholly-owned subsidiary of BNP Paribas, purchased all of the shares of Fortis Capital Corp. On June 30, 2010, BNP Paribas and Fortis Capital Corp. transferred the entirety of their holdings in the Issuer to BNP Paribas VPG SemGroup, LLC.

3. 4,678,818 shares are owned by BNP Paribas VPG SemGroup, LLC, a direct wholly-owned subsidiary of BNP Paribas VPG Master, LLC, which is a direct wholly-owned subsidiary of BNP Paribas. Remarks:
