#### SUNOCO LOGISTICS ANNOUNCES NINTH CONSECUTIVE QUARTER OVER QUARTER DISTRIBUTION INCREASE OF AT LEAST 5 PERCENT AND EARNINGS CONFERENCE CALL DATE

#### *The Partnership announces* 37<sup>th</sup> successive quarterly distribution increase overall

PHILADELPHIA, July 24, 2014 - Sunoco Logistics Partners L.P. (NYSE: SXL) (the "Partnership") today announced that Sunoco Partners LLC, its general partner, has declared a cash distribution for the second quarter 2014 of \$0.365 per common unit (\$1.46 annualized) to be paid on August 14, 2014 to unit holders of record on August 8, 2014. This represents a 5 percent increase over the first quarter 2014 cash distribution of \$0.3475 per common unit (\$1.39 annualized) and a 22 percent increase over the second quarter 2013 cash distribution of \$0.30 per common unit (\$1.20 annualized). This is the thirty-seventh successive quarter the Partnership has increased its distribution.

"We are pleased to announce our ninth consecutive quarter over quarter distribution increase of at least 5 percent," said Michael J. Hennigan, president and chief executive officer. "We continue to execute our strategy for growth. We are committed to growing stable, ratable cash flow for the Partnership and distributing that cash to our owners."
