- The Class B units will convert automatically into common units on a one-for-one basis, with 50% of the outstanding Class B units converting into common units following the payment date of the fourth quarterly distribution following the closing of the merger and the remaining outstanding Class B units converting into common units following the payment date of the eighth quarterly distribution following the closing of the merger.
- The reporting person received 10,166.264 Class B units as a payment-in-kind distribution on 601,113.188 Class B units owned on the distribution record date.
- The reporting person received 2,950.115 Class B units as a payment-in-kind distribution on 174,435.051 Class B units owned on the distribution record date.

Remarks:

Contributions to the EUPP plan are used to purchase Inergy, L.P. Common Units at the end of each quarter. On January 12, 2004, the Common, Senior Subordinated and Junior Subordinated Units of Inergy, L.P. underwent a two-for-one split.
